- 1. Call to Order: Abby Bigford, Vice-Chair, called the meeting to order at 1:00 PM
- 2. Roll Call:
 - a. Present: A. Bigford, J. Clark, G. Freeman, J. Ludwick
 - b. Absent: B. Johnson
- 3. Public Comment:
 - a. Two KLSWA Employees spoke. Both said, "They hoped their comments would not be held against them at work."
 - b. One employee stated that, "On one occasion he said something that upset Daryl so badly that Daryl's face got all red and his fists were balled up. He thought he was going to get hit, or worse."
 - c. The second KLSWA employee said, "He has not had a performance review in 5 years." He said, "Daryl manipulates people and the very high turn-over rate is because of Daryl and how he treats people."
 - d. The third speaker was the Operating Engineers Union organizer, Mike Pekler. He said he hadn't planned to speak but wanted to support #1 and #2. He simply said, "these people are a family."

- iii. Mr. VanDyke shall immediately return all Authority property including keys, access devices, electronic equipment, credit cards and Authority records to the Commission Chair.
- iv. Motion passes Bigford yes, Freeman yes, Ludwick yes. Clark no.
- c. Motion by Bigford, supported by Freeman, as follows:
 - i. Motion that Kazimir (Kaz) Bajc be appointed interim Manager of the Kalamazoo Lake Water and Sewer Authority, until further notice.
 - ii. Motion passes Bigford yes, Freeman yes, Ludwick yes. Clark no.
